




This is to discredit the civil rights ovement as a threat to America security, politics and culture






The Cover

Persons utilizes this device to bolster his argument, asserting that the actions of a few threatens the American Livelihood American culture - As the protests unfolded, law enforcement introduced K9 units as a method for crowd control (Berger)


